1) Trust Overview

Ahura Support ("the Trust") is a public Charitable Trust registered under the Maharashtra Public Trusts Act, 1950. The Trust received the approval under the Foreign Contribution Regulation Act, 2010 vide approval letter dated 12th February 2024 bearing registration number 083781738.
